2024 Boston Resident Golf Season Permit Lottery Application

The Parks and Recreation Department will be offering a limited amount of season golf permits for the 2024 golf season. There will be a random draw lottery to determine the winners. The drawing will take place Monday May 13, 2024 at 9:00 A.M. in the Function Room at The William J. Devine Golf Course at Franklin Park.

The lottery is only open to Residents of Boston.

If you are not a resident do not submit an application. It will not be processed!

To enroll in the lottery please fill out the form below and **hand deliver** the application to either golf course. Incomplete applications will not be accepted. Applications mailed will not be processed. When the application is delivered, the golf staff will review the application and if the required documentation is provided, the applicant will be assigned a lottery number. Incomplete applications will not receive a lottery number.

The deadline to enter the lottery will be May 6, 2024 at 5:00 P.M.

The 2024 Individual Season Permit:	Resident of Boston: \$1,700
The 2024 Individual Senior Permit Holder: (A Senior is eligible for this permit if you will 65 years of age or older before 12/1/24)	Senior Resident of Boston: \$1,400

PLEASE

- You must include a copy of a utility bill (water and sewer bills will not be accepted) and a copy of your driver's license (or MA ID) for proof of residency.
- Season permit applications without residence proof and payment will not be processed.
- Season permits are non-transferrable and non-refundable.
- All season permits are valid from date of purchase and **expire on 2/28/2025**.
- The season permit is for unlimited green fees only at both golf courses and does not include cart usage or tournament play.
- Please Note: Credit Card payments have a 3% transaction fee
